### **OFFICIAL RULES**

Unless otherwise specified in this offer, online/telephone (donation) entries must be received by 12/31/20 and mail entries must be received by 12/9/20. **ELIGIBILITY.** The Raffle is open to legal residents of the 50 United States and the District of Columbia, Canada (excluding Quebec), UK and other countries only where offered and permitted by law, who have reached the age of majority in the jurisdiction in which they reside. #### **To Enter Without Donating:**

Handprint your name, address, day/evening phone number and email address (if available) on a 3"x5" card and send to: Mesivta Netzach HaTorah, 111 Irving Place, Woodmere, NY 11598. Indicate one option from (i)-(vi) above on the front of your envelope to indicate the drawings you wish to enter. For example, if you write (iv) on the front of your envelope, you will receive seven

(7) entries. Your mailed entry must be postmarked by 11/30/20 and received by 12/10/20. Limit thirty (30) entries per person regardless of the method of entry.

**SELECTION OF WINNERS.** Winners will be selected on or about December 31, 2020 in a random drawing from among all eligible entries received. The odds of winning depend on the number of eligible entries received. Decisions of the judges are final. Winners will be notified by email and/or US mail, in the sole discretion of the Sponsor. If a potential winner fails to respond after two notices, his/her prize may be forfeited and an alternate winner may be selected. If offered in Canada, Canadian winners will be required to answer a mathematical skill testing question as a condition of receiving a prize.
